- 7. Variance Application Jessica Cope, 92 Edgewood Request for variance Article XII, Section 12 Town of Alma Zoning Ordinance living temporarily in a camper. Lee Phillips went over the applicable zoning ordinance and variance procedures. Jessica Cope informed the board of her wishes to stay on property to watch her inventory for freezes and for losses. She does have plans of a permanent structure with living quarters. She is asking for a seasonal variance to live on the property for this year and next. She is also asking to use the dumpsters for her personal trash. She does have permanent water and sewer on the property. Lee Phillips advised that the property being zoned MU allows for the combined use of the property.

- 12. Renewable Social Benefit Funds Mark Aumen Renewable Energy Project. Mark Aumen and Brad Griffin were present to discuss the possibility of utilizing the xcel infrastructure to provide solar power to the town. Staff is seeking approval for the go ahead of this project. We need about 2 acres for the solar field. The Board gave the go ahead to the project.
- 13. Legal Report Lee Phillips relayed on information service plan for the Alma Placer special improvement district. The plan needs some additional work. It will be an independent taxing unit. The second issue is annexation petition. It is critical that the town control its own destiny. A waste water facility should be part of the discussion. We will need water consultation. Lee has some recommendations.
- **14.** Administrator Report Nancy Comer gave an update on Bingo to be Thursday. Illegal trailers are being addressed. Bob Kassel as code enforcement officer is writing correspondence.
- 15. Board Comments: Saam Golgoon asked about the luminance of the signs. Maybe the lights will help.
