- 3. Motion to approve the agenda by Minette Doss. Second by Matt Cole.
- 4. Motion to approve the Minutes of the August 5, 2014 meeting with corrections by Matt Cole. Second by Mel Kassel.

- 6. Citizens Comments: Ruth Ann Sherrier and Nancy Wood from the Bristlecone Montessori School were present to voice concerns about a possible Retail Marijuana shop going in on Main Street. No one has submitted an application at this time for a license. If one is submitted the property will be posted for public comment.

- 7. Public Works Report Nick Radtke/Tim Zingler Tim Zingler reported there have been bears in town. Everyone should talk to their neighbors and educate them on leaving trash out. Nick Radtke reported that the water plant is producing about 30,000 gals a day. This is a good average. Nick Radtke reported the orange fence mine reclamation is scheduled to start. The Town will be helping with dirt moving.
- 8. Water Augmentation Court Case has been heard in court. The final decree has been issued. This will help guide the Town for the next 100 years. Lee Phillips seconded that thought. This is a huge success for the Town. Cudos to the Board for pursuing this! The next step will be to develop storage.

- 10. Police Report Chief Kimsey reported 40 out of 62 shifts covered. The Festival in the Clouds went very well as expected. There were 89 citations issued, 61 warnings, 9 agency assists, 7 calls for service and 11 new case reports. 2 of those cases are still open. The rest are closed.
 - Bike Race USA Pro Challenge is coming this Friday. Hwy 9 will be closed for that time period of the race. Discussion of Speed Limit on Buckskin Rd. Discussion was held. No passing signs will be obtained to try to alleviate some of the safety issues.
 - Discussion Charles Quist code enforcement action. Chief Kimsey asked the Board for direction. The Chief was instructed to get bids for the cleanup of the project and bring them back to the Board.

 - Andrew Zimmerman made a motion to adopt resolution 2014-04. Minette Doss seconded. All Ayes. Motion Carried.
- 14. Legal Report Lee Phillips reported he went to dinner to celebrate his mother's birthday. Happy Birthday Mrs. Phillips!!!

Lee presented the Board with a copy of the final order from the Court dis allowing Rich Wyatt any permission to use an Alma Badge to identify himself.
